To ensure complete safety & protection of each child coming to school we have stated **Mandatory Guidelines** below, we seek your cooperation & support in adhering to the same.

1. Parents need to send their consent on school Email ID (jpsindausa@gmail.com) latest by 12:00 noon Thursday, 14<sup>th</sup> October 2021 failing which the student will not be allowed to attend school.

2. Students have to come in **Regular School Uniform** only. Uniform Counter will be open in school on **Sunday, 17<sup>th</sup> October 2021 from 11:00 am to 1:00 pm**.
3. Every student must wear a mask at all times & needs to carry a hand Sanitizer.
4. Students have to carry their own Tiffin & Water Bottle. Sharing of food & water is not allowed. Students have to eat their Tiffin in the class room only. Cafeteria will not be functioning.
5. Students need to carry their own stationery-Textbooks, Notebooks, Pen, Pencil etc. No sharing will be allowed.
6. If any student is sick we would expect him/her to stay at home till the time he/she is totally fit & fine. On rejoining of school he/she will have to submit a medical fitness certificate.
